Dear readers,

Public services have been high on the agenda this month. The Commission published its communication on the internal market in the 21st century,

which unfortunately failed to take account of our proposal for a framework directive, a point which we deeply regret. Let us remember that the mayors of ten European capital cities backed this idea in a joint statement. We regret that the Commission has missed the opportunity to guarantee sufficient respect for the role of public services. We reiterated our position to the President of the Commission when we handed in our petition, reminding him of the importance of the social dimension of the internal market. It is no good merely paying lip service to this social dimension, it needs to be followed up by some action. Furthermore, the Communication does not call into question the benefits of liberalisation and privatisation, which is why we have asked the Commission to conduct its promised analysis of the consequences of liberalisation, and in particular its effects on employment.

However, better news is that the Commission has signalled a revision of the directive on European Works Councils. We also welcome the agreement concluded by the new European company BASF SE, based in Ludwigshafen, on worker participation. This agreement is a pioneer for greater co-decision in Europe.

In the same vein, the Steering Committee has confirmed the great political importance of the judgements by the European Court of Justice in the Laval and Viking cases, expected next month.

The next EU Employment and Social Affairs Council in early December should be addressing the two issues we are closely monitoring: the directives on working time and on temporary workers.

#### **Public services: mayors of ten European capital cities support ETUC petition**

09/11/2007 – On the initiative of [John Monks and of Freddy Thielemans, Mayor of the City of Brussels](#), the mayors of ten European capital cities (**Brussels, Paris, London, Luxembourg, Lisbon, Sofia, Amsterdam, Tallinn, Vienna and Nicosia**) have signed a [declaration for "quality public services, accessible to all"](#). In response to recent privatisations that threaten to marginalise specific areas, the mayors of these cities supported the [ETUC petition calling on the Commission to propose European framework legislation on public services](#) in Europe. Within the context of this campaign, [John Monks and Carola Fischbach-Pyttel](#), General Secretary of the European Federation of Public Service Unions (EPSU), presented a petition [to José Manuel Barroso, President of the European Commission, with more than half a million signatures](#).

### EWC Directive revision in the Commission work programme for 2008

The ETUC is pleased that European Commission President **José Manuel Barroso**, in the **European Parliament debate on the legislative work programme 2008**, confirmed his intention to submit a proposal to amend the European Works Councils (EWC) Directive. ### More worker consultation in Europe with BASF SE

22/11/2007 – BASF SE, a new European company (SE) with more than 60,000 employees in 22 EU Member States plus Norway and Switzerland, **has concluded a major agreement on workers' participation**. Guaranteeing the participation of representatives from the European Mine, Chemical and Energy Workers' Federation ([EMCEF](#)) on the BASF Europa Betriebsrat (Works council) and the SE supervisory board, **this agreement marks the most significant step forward so far towards broad, compulsory worker participation in a European company**.

## Focus on the EU and trade union positions



### ETUC demands a Euro area interest rate cut

08/11/2007 – As the European Central Bank (ECB) board met in November, the **ETUC published a report making the case for cutting interest rates in the Euro area.**

Without such a move, the European economy will have difficulty over the coming months handling the shocks generated by recent interest rates hikes, the progressive Euro appreciation against the dollar, and fall-out from the sub-prime crisis. To avoid this, the **ECB should intervene to cut interest rates now.** Thus the ETUC regarded the decision not to change interest rates as disappointing.



### EU needs real solutions to excessive wage moderation

13/11/2007 – For a number of years, the European Union **has been experiencing stagnating real wages and excessive wage moderation.** Systemic wage moderation **undermines domestic demand in the European internal market.**

Even if **Eurogroup finance ministers** are aware of this situation, their **proposed solution of 'profit sharing'** is risky, because it will substantially benefit 'strong insiders' (like managers and executives), with no real impact on average workers.

### EPA negotiations: Commission should do the right thing

19/11/2007 – As the EU [General Affairs and External Relations Council](#) met, the **ETUC and International Trade Union Confederation (ITUC) repeated their call for an extension of the Economic Partnership Agreements (EPA) negotiating deadline.** Many countries are not in a position to sign these agreements.

In the **view of the ETUC and ITUC, it is time to stop the deadline game and look for creative solutions to the African, Caribbean and Pacific countries' development needs.**

## An internal market without a social dimension?

20/11/2007 – The European Commission defined a package of initiatives aimed at modernising the European single market. For many months the ETUC has been calling for a framework directive dedicated to protecting public services.

**Consequently the sense of disappointment was very strong. In rejecting the idea of a framework directive, the Commission has missed an opportunity to ensure that public services are fully safeguarded.** Although it announced plans for a new Social Agenda, the Commission's commitment to the social dimension of the internal market seems to be just a formality.

The internal market should not bring gains for business alone, but must also benefit workers.

## Laval and Viking cases: ETUC places its hopes in the ECJ judgements



On next December, the European Court of Justice (ECJ) will rule on the **Laval and Viking cases**. The outcome of these cases is fundamental for the future of Social Europe.

The European trade union movement believes that **the industrial action taken in both cases was in full conformity with the principles and requirements of EC law. It was necessary to defend the principles of non-discrimination and of equal pay for work of equal value regardless of nationality.**

The ETUC will organise a press conference in Brussels on 18 December following the rulings.

## Flexicurity: European Parliament in favour of more balanced principles

29/11/2007 – The plenary assembly of the European parliament adopted by a large majority a **report on common principles of flexicurity**. The key flexicurity principle are, among others, the promotion of stable employment relationships, action against abusive practices in non-standard contracts, gender equality, the work-life balance and the social dialogue. **The Commission and the Council should take this into full account when they come to agree on European principles of flexicurity.**

## The ETUC for an ambitious post-Kyoto agreement

30/11/2007 – United Nations will organise in Bali from 3 to 14 December a conference on climate change with the aim of deciding the launch of negotiations on a global and ambitious agreement post 2012.

**The ETUC calls for a firm and ambitious commitment from all the developed countries to reduce their greenhouse gas emissions by at least 30% for 2020.**

The new agreement must include a dimension dedicated to the intermeshing of climate change and employment policies.
