

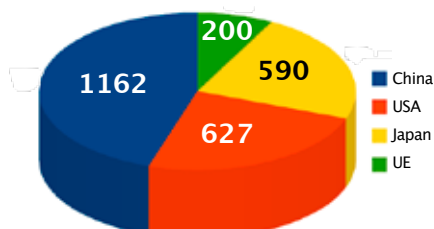

FIGHT THE CRISIS
PUT PEOPLE FIRST



Dear Readers,

All the unions have mobilised to defend the interests of those affected by or likely to be affected by the violence of this crisis. In March, there were a number of high-level meetings and actions during which we had the opportunity to make our voice heard. We are remaining on the offensive. It is our opinion that this crisis is, of course, extremely serious but it is not insurmountable. It requires the introduction of bold and coordinated measures for both the short and long term to tackle the question of massive redundancies, unemployment and jobs. We have to keep workers on the job. We think that this crisis can be defeated if we invest in a New Social Deal that puts the accent on safeguarding jobs and investing in tomorrow's jobs, on lifelong training especially for young people, and on more appropriate use of European funds like the European Social Fund or the Globalisation Adjustment Fund.

The Employment Summit that was set to take place in Prague on 7 May has been downgraded to a Social Troika, a move we see as a bad signal even as many fear losing their jobs. However, we will not turn down the invitation to make our messages heard there, in spite of the meeting's more limited impact. These messages are certain to carry a particular resonance because they will also be relayed, one week after the Social Troika, by the European action days we are organising in Madrid, Brussels, Prague and Berlin from 14 to 16 May.

CONFERENCE : The financial crisis and the European Employment Strategy



05-06/03/2009 – At the beginning of March, ETUC organised a conference on [the financial crisis and the European Employment Strategy](#) in Brussels. Several trade union leaders, European social partner representatives, as well as European Commission representatives took part in the conference. During the conference, **ETUC sound once again the alarm about the negative impact of the financial crisis on the real economy**, in particular on employment. According to ETUC forecasts, **the unemployment rate in Europe could exceed 10% in 2009**, with an increase of about four million more jobseekers than in 2008. The European trade union movement demanded an **extraordinary European plan against redundancies and for securing careers**.

ETUC CAMPAIGN Fight the crisis: put the people first

ETUC has just launched a **European campaign**, entitled [Fight the crisis: put the people first](#). For the European trade union movement, it is **unacceptable** for workers and citizens to pay the price for a crisis they did **not cause**.

The key events of this campaign will be the four European demonstrations, which will take place **from 14 to 16 May** in Madrid (14/05), Brussels (15/05), Berlin and Prague (16/05).

ETUC is calling for a **New Social Deal** in Europe based on a key five point plan:

- an **expanded recovery programme** to provide more and better jobs;
- **better pay and pensions**, and stronger welfare states;
- an **end to the recent decisions of the European Court of Justice** favouring market freedoms over our fundamental rights and collective agreements;
- **effective regulation of financial markets**, leading to a fair distribution of wealth;
- a **European Central Bank committed to growth and full employment**, not just price stability.

This wide-ranging campaign will serve to make the governments assume their responsibility of providing European responses to this crisis, rather than simply taking case-by-case measures.

“ Fight the crisis: put the people first ”

ETUC General Secretary John Monks presents the measures proposed by ETUC to face the economic crisis and the main events of the campaign ‘Fight the crisis: put the people first’.

Interview with John Monks



1) Which lessons can be learnt from this crisis? And once the crisis will be over, how can we avoid going back to ‘business as usual’?

John Monks (JM): Indeed, we must learn lessons from this crisis. Essentially, modern capitalism has had a heart attack and the damage is causing a worldwide recession, which risks becoming a new great

depression like in the 1930s. The lessons that we have to learn from this crisis are not just about the financial system and its excessive speculation, they are also about the way companies run their affairs, the concept of shareholder value, short-term perspectives, as well as about the need to build a fair and more social economic system. This is the ambition of the world trade union movement and ETUC. Never again, must the excesses of the banks and of many of the rich and powerful be allowed to dominate democracy in the way in which they have done up until now. Today, people are looking towards governments and not the markets – this is a big opportunity for the trade union movement.

To avoid going back to ‘business as usual’, we need a fundamental revision of modern capitalism, and stronger financial regulation is just a start. We also need to introduce new checks and balances in the way companies run their affairs. This should include stronger trade unions with greater power and influence in corporate governance. We can hold entrepreneurs to fairer standards than they have become used to in the past 30 years.

2) To fight the crisis, ETUC proposes a New Social Deal. Which are the key elements of this deal?

JM: The first element is that we are looking for a bigger recovery plan than that Europe has so far produced. Industrial output is down 4% in the past quarter. The recovery plan so far is about 0.9% of gross domestic product (GDP) and, frankly, while it is going in the right direction, it is not anything like enough to deal with the crisis.

Secondly, it is very important to put specific measures in place that support people who have been made redundant and face unemployment today; this includes schemes promoting short-time working and maintaining workers’ purchasing power. It is very important to keep up wages, benefits and pensions so that people have money to spend. This, in turn, will keep the real economy going instead of engaging in a downward tailspin.

Thirdly, we would like to see something done for young people: school and college leavers are going to enter the labour market in a very difficult situation. To overcome these difficulties, they will need particular support to continue education and training.

Fourthly, vocational training services should be extended such that people are equipped for the new jobs of the future. Fifthly, European funds, such as the European Globalisation Adjustment Fund and the European Social Fund, should be made available on an emergency basis to support European-wide employment creation projects.

3) How does the European trade union movement judge the Commission’s and Council’s approach to the crisis? What do you think about the fact that the European Council has downgraded the Employment Summit scheduled on 7 May in Prague to a Social Troika meeting?

JM: The Commission and the Council are not moving fast enough. They are too cautious in their initiatives and actions, as well as risking of being accused to act in compliance. The recovery plan was useful and the coordinated bank rescue was a good move; however, more moves are required and a New Social Deal in particular. This deal should contain specific measures to help workers who are paying the price in terms of jobs and wages for the speculation and irresponsibility of bankers and others. So, our demands are more measures and funds, and those quickly.

Concerning the Employment Summit on 7 May next, I regret the decision of the European Council to organise it on a Social Troika basis. This decision is a very bad signal to citizens and workers as it suggests complacency. It

gives the impression that European leaders are not sufficiently concerned about unemployment and we lose now a major opportunity to be heard at the very top level. Nonetheless, we will take part in this 'diminished' summit in the interests of European workers, but it underlines our call to people for supporting and joining the European action days in mid May. We need a European-wide coordinated effort on jobs and, for the time being, we are not getting it.

4) ETUC has just launched the campaign 'Fight the crisis: put the people first'. Which are the main events of this campaign?

JM: We are organising three European actions days in four European capital cities on 14–16 May. The Euro-demonstrations will take place successively on Thursday 14 May in Madrid, Friday 15 May in Brussels and

Saturday 16 May in Berlin and Prague. We invite all our member organisations to participate massively in these four Euro-demonstrations, backing our demands to put the people first in the fight against the crisis.

5) Why is it important for ETUC to support the national protest mobilisations which reveal rising social unrest in several EU countries such as in France or Ireland?

JM: We have been warning European authorities that social unrest would develop and accelerate. The mood is changing from worry to frustration and anger, and the demonstrations in France and Ireland, in particular, are showing that people will not put up with bank rescues and misery for many in exchange. We are channelling some of that frustration and anger in our European action days.

European solidarity is necessary to fight the crisis

02/03/2009 – The extraordinary European Council on 1 March 2009 decided to **assist central and eastern European Member States** in dealing with the economic crisis on a case by case basis. For ETUC, **this approach is insufficient**. The European trade union movement called on the European Commission **not**

to allow the International Monetary Fund to abuse currency crises by imposing lending conditionalities undermining the European Social Model.

Downgrading of the Employment Summit of 7 May 2009: a bad signal to European citizens
