UNIONS UNITED AGAINST PRIVATISATION IN THAILAND

In their unprecedented anti-privatisation campaign in Thailand, unions have demonstrated non-stop since 23 February against the privatisation of the national electricity company EGAT. Private sector unions, NGOs, academics and public managers are also supporting the campaign. The Thaksin government has tried unsuccessfully to use scare tactics against the unions, warning that the stock market will crash if they don't privatise, that Thailand won't be able to afford new investment in electricity generation, that only by privatising will the government be able to set up an independent regulator to control prices! And finally, the government has banned PSI Utilities Officer from speaking to the demonstrators, a warning that the unions will ignore.

The government then tried to pay off the workers, offering them a special deal on the shares of EGAT, and regulating the share allocation such that all Thai citizens can buy EGAT stock (in response to the previous privatisations, where the vast majority of shares went to Thaksin insiders and to wealthy foreign investors). The unions refused the offer and continue to insist that the issue of privatisation go to a national referendum, which the government is too scared to hold, especially with national elections less than one year away.

28 APRIL: SAFE AND HEALTHY WORK FOR ALL

Workers' Memorial Day is held each year on 28 April to remember those who die or are injured as a result of a workplace accident or a workplace-related illness. Each year, 2 million people are killed, 1.2 million people are injured and 160 million people are diseased because their employers decide that their safety is not an important priority. Unlike those dying in war or major incidents, these victims are not publicly remembered. Workers Memorial Day remembers them all as part of the campaign to make workplaces safer, to reduce deaths, injuries and illness caused by work.

Workers Memorial Day is recognised as a national day in nine countries: Peru, Argentina, Bermuda, Canada, Brazil, Dominican Republic, Portugal, Spain and Taiwan. Unions in nine more countries are pursuing government recognition in 2004: Benin, Czech Republic, Finland, Hungary, Malta, Nepal, New Zealand, Romania and Singapore. The primary theme for 2004 is "Safe and Healthy Work for All", with "Employer Accountability" as the secondary theme. Make 28 April 2004 a day to remember! The Labor and Worklife Program will release results of the first Global Labor Survey in May 2004 and anticipates worldwide attention. GLOBAL UNIONS STATEMENT FOR IFI SPRING MEETINGS

Global Unions' statement for the spring meetings of the IMF and World Bank (Washington, 24 -25 April 2004) has been finalised. These meetings are usually attended by development ministers, finance ministers or central bank governors. Global Unions' recommendations to the meetings include a call for a number of important changes in the way that the IMF and World Bank operate. The IFIs can respond more quickly and effectively to the need for change by engaging in regular exchanges with trade unions, especially when their interventions have an impact on labour, and by taking account of the results of these meetings when designing loans or formulating country-level policy advice. The full statement (11 pages), a summary (2½ pages), and a letter (1 page) that affiliated organisations may wish to adapt and use for submitting the statement to their government before the meetings are all available on the PSI website www.world-psi.org
