## Solidarity support

PSI affiliates' response to our requests for solidarity for the tsunami in the Indian Ocean and the Pakistan earthquake have been outstanding. We have recently put 100,000 € towards rebuilding housing in Sri Lanka and another 100,000 € towards the ICFTU Global Unions fund for workers' centres. ## WTO Ministerial Conference

The WTO 6th Ministerial Conference is being held in Hong Kong, 13-18 December. PSI is taking part in the activities surrounding the meeting. Our focus is particularly on the impact of GATS (the General Agreement on Trade in Services) which has the potential to hasten privatisation and liberalisation of public services around the world. It also allows challenges to important laws and regulations that protect communities, on the basis that these inhibit free trade. PSI identifies the existing GATS provisions as a major obstacle to promoting quality public services.

Workers' Voice @ WTO is a new website that will give daily updates for the duration of the Hong Kong meeting so that you too can follow the negotiations. ### **The coming demographic shift**

Many countries are beginning to experience a great demographic shift that will have profound effects, as huge numbers of working age people all near their retirement age over a quite brief time. A new PSI publication presents a series of steps to deal with this looming social phenomenon. ### **Migration and women health workers project update**

Three partnership meetings were held in 2005 by the national coordinators from participating unions in the PSI Migration and Women Health Workers Project. The meetings were held in Kenya, the Philippines and Barbados in September, October and November. They brought together participants from Kenya, South Africa, Ghana, USA, UK, Canada, the Netherlands; the Philippines, Sri Lanka, Fiji, Japan; Barbados, Chile, Ecuador and Spain. A major objective of the meetings was to

develop a pre-decision kit for migrant health care workers. Through this kit, migrant health workers will be provided with information on how to join unions in the receiving countries, know about their legal and employment rights, find out details on living conditions, and other information describing the real costs and benefits of migration. ### **Czech unionists rally in support of Labour Code**

On 26th November, 30,000 Czech trade unionists held a rally in Prague to support the government's draft new Labour Code. The draft guarantees decent working conditions and cancels some obstacles to collective bargaining. It was passed by the Chamber of Deputies, but is facing opposition by employers and business. However, the resident of the Czech Economic Chamber said that the senior ruling Social Democrats (CSSD) and the opposition Communists (KSCM) have already reached agreement to push the Labour Code through anyway. Employers may still try to push through a Labour Code worked out by the right wing parties which would be based upon a fear of job loss. The unions will continue to campaign against any changes to the Code.

## No to reform, yes to quality public services

The Nigerian government's reform of the civil service includes a plan to cut 3,000 jobs. PSI affiliates held a protest rally in Abuja in November in which they appealed to the government to put the retrenchment plan on hold and, instead, to give public sector workers the opportunity to make quality public services their goal, which would in turn make the civil service more efficient. The chairperson of PSI's National Coordinating Committee in Nigeria, Chief Nkem Nath Nwauzer, said, "We believe that quality public services in Nigeria will mitigate the subjugation of civil servants to constant threats of job insecurity through retrenchments that are unwarranted and unjustifiable by any governments in power in Nigeria. Besides, quality public services, which is the initiative of PSI, will provide jobs for youths to be gainfully employed". ## General Agreement on Public Services

PSI will be working with partner organisations in 2006 to promote a General Agreement on Public Services (GAPS). This Agreement provides a means for winning government commitments to the provision of quality public services, and offers an alternative to the WTO approach contained in the GATS. ## UNISON's action plan for cleaner hospitals

UK union UNISON is running a quality campaign on hospital cleaning to save thousands of lives every year. In 1986 there were 67,000 full-time cleaning posts in the NHS. Now there are only 36,000 full-time equivalents. Dirty hospitals increase the risk of hospital acquired infections and are unacceptable to patients and staff. Yet the number of cleaners working in the NHS has almost halved in the last 18 years. UNISON believes that more and better-trained cleaning staff are key to improving standards of hospital cleanliness. Hospitals need to have sufficient, properly trained and equipped cleaning staff, who are valued and rewarded as an important part of the healthcare team.

UNISON General Secretary Dave Prentis said, "Spiralling hospital acquired infections cost the NHS more than £1 billion and at least 5,000 lives a year. We want to shift the focus onto the failures of the
