## Ecuador: Union leaders' case to be heard on 26 September



Back in November 2007, PSI launched an Urgent Action regarding arrest warrants which had been issued for Luís Muñoz Pasquel and Girard Vernaza Arroya, leaders of the National Federation of Judiciary Workers of Ecuador (FENAJE). They are accused of criminal damage to a public building and of unspecified acts of terrorism. The case against the two leaders will be heard on 26 September 2008 and PSI is asking affiliates to respond urgently by sending as many letters of protest as possible before this date. The number of trade unionists killed in Colombia for this year has almost reached the total number of those killed in 2007. On 23 August, José Omar Galeano Martínez, President of the Colombian Lottery Workers' Federation (FECOLOC) was the 38th trade unionist assassinated this year. ## Australia: Mothers losing out on promotions



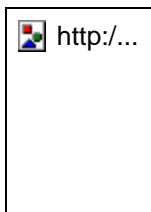
A workplace survey in Australia has shown that women who have taken maternity leave are less likely to receive promotions after their return to work. Sixty-five percent of female public servants who took maternity leave in 2000-01 had not been promoted as of June 2007. In the same period, just 42 per cent of women without children had not received a promotion.

## Filipino nurses still underpaid

More than 100 nurses gathered for a demonstration outside one of Manila's government hospitals on 24 July in response to the delay in applying salary increases for nurses. The Nursing Act of 2002 stipulated the minimum monthly compensation for entry-level nurses, but six years later, many nurses are still grossly underpaid. Annie Enriquez-Geron, PSLINK General Secretary, confirmed that many nurses wouldn't have left the country had they been accorded a living wage at least. [Click here for more](#)

Over 3,000 trade union members, employees of gas distribution companies, picketed the Cabinet of Ministers of Ukraine. PSI officers Dr. Jorge Mancillas and Svend Robinson represented the organisation at the 17th International Conference on AIDS, held in Mexico City on 3-8 August. They drew attention to the need to protect health workers from occupational exposure to HIV and provide adequate treatment to medical personnel infected while carrying out their duties, particularly the promotion of safe injection devices, access to post-exposure prophylaxis, and application of guidelines developed by the WHO and ILO. ## **Indian contract workers' regularisation success**

PSI affiliate the Delhi Transport Corporation Employees' Congress was on strike for 36 days in July/August, demanding the regularisation and promotion of 3,000 contract employees. In a similar case, contract workers represented by the All India Irrigation Employees Federation saw their employment regularised as well. It involved 7,000 workers from Uttarpradesh state and 12,000 from Madhyapradesh state. These successful cases were the fruit of PSI Indian affiliates' National Coordination Committee campaign for dealing with contractualisation and outsourcing in the public sector. Up to 150,000 Scottish council workers staged a 24-hour strike on August 20. The workers, members of the GMB, Unite and Unison trade unions, all of which are PSI affiliates, are in dispute with local authority employers over pay. The staff recently voted to reject a 2.5 percent pay deal over three years. On the same day, 5,000 council workers, members of PSI affiliate the Public and Commercial Services (PCS) trade union, also held strike action in Scotland in a separate dispute. The Health Services Workers Union (HSWU) of the Ghana TUC has urged government to pay health service workers the salary adjustments awarded to all public sector employees since 2006. The delegates also requested government and their employers to base retirement benefits on the current terminal salaries and not the 2005 levels. 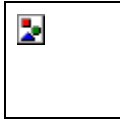
