Toward A World Reserve System

In the long run, a single national currency cannot provide the basis for a stable, international monetary system. Recognition of this fundamental problem provided the rationale for creating the IMF's Special Drawing Rights (SDRs) in the 1960s. The global economic crisis that began in 2008, shows that the dollar standard - in place since the early 1970s - places unfair burdens on developing countries and creates a system that is inequitable to the developing world. the United Nations on November 5th and a daylong conference on November 6th organized by the FES in cooperation with the Initiative for Policy Dialogue and with support from the Ford Foundation at Columbia University brought experts in the history, alternative forms of

Beginning in the fall of 2008 under the aegis of the first G20 leaders meeting, national governments, central banks and international financial institutions organized themselves with blinding speed to rescue the global financial system.
