Upcoming Event: "Afghanistan's Region 2014 and Beyond: Joint Declaration on Regional Peace and Stability"

The future development of a stable and prosperous Afghanistan is of major importance for the peaceful development of South Asia, especially after the withdrawal of ISAF by the end of 2014. In order to build mutual understanding and to formulate policy guidelines for the region the Friedrich-Ebert-Foundation (FES) established a network of policy groups in Afghanistan as well as Central Asia, India and Pakistan in 2012. The participants of this network - policy makers, scholars, journalists, former diplomats and military leaders - met on a regular basis during the past two years. The result of these efforts - a joint declaration - will be presented by FES New York at the United Nations on February 3. Among the panelists will be Ambassador Mahmoud Saikal from the Afghanistan Policy Group and former Deputy Minister of Foreign Affairs and Khalid Aziz from the Pakistan Policy Group and former Chief Secretary Khyber Pakhtunkhwa/North-West Frontier Province.

Upcoming Event: "Social Protection: A Universal Rights-Based Development Goal"

Social protection is one of the foundations for inclusive, equitable and sustainable development and addresses simultaneously the economic, social and environmental dimensions of sustainability. Moreover, it has a transformative role in contributing to long-term inclusive and sustainable growth while also enhancing resilience against natural and manmade disasters, as well as economic and social crisis. A universal right based development goal for social protection should be part of the Post-2015 Development Agenda. A proposal for such an Development Goal was developed by the Global Coalition for Social Protection Floors, a coalition of more than 70 civil society and trade union organizations from all over the world, and will be presented in a side even at the occasion on the 52nd session of the Commission for Social Development. Organised by the Global Coalition, the Friedrich-Ebert-Stiftung and the International Labour Organisation the purpose of the side-event is to initiate a wide debate among governments, civil society and social partners on the objective and content of the proposal for a Social Protection Development Goal.

New Publication: "Whose development, Whose UN? Reclaiming the UN's values-based framework"

With the Millennium Development Goals (MDGs) expiring in 2015, the United Nations is debating a new set of goals to guide future multilateral cooperation for development at a time when overlapping global risks - from the climate, poorly regulated finance and failed human security - present unprecedented challenges to international cooperation. To finance future development, the UN system is turning more and more to the private sector for answers without reflecting on the negative results that market-led development might bring. This Perspective takes a hard look at the state of the UN's historically values-based framework and offers a vision for reclaiming that framework, a vision that suggests accountability needs to be at the core of development.
