Dear Colleagues & Friends,

In a few days the world will be commemorating the 70th anniversaries of two landmark agreements: the *Convention on the Prevention and Punishment of Genocide* on December 9, and the *Declaration of Human Rights* one day later on December 10.

After the atrocities and destruction of World War II, the international community was committed to formalizing the foundations for peaceful coexistence through international agreements. Today, we see ourselves defending these foundations against a rising tide of doubt and critique towards international agreements at large - as we can see currently with the controversial debates around the Global Compact for Safe, Orderly and Regular Migration which will be adopted by UN Member States in Marrakesh on December 10 and 11, 2018.

International agreements are not an end in itself, they serve the larger purpose of supporting national governments in their endeavors to better the lives of their citizens. It is as simple as that: border transcending issues need multilateral cooperation.

Moreover, agreements need to be implemented to really make a difference in people's lives. The consensus of the Responsibility to Protect (agreed upon by Member States in 2005), for example, has had little impact on the ground so far. Between 2010 and 2016, the number of violent conflict worldwide has doubled and the number of deaths that occurred as a result has more than tripled. So things on the ground have clearly not moved in the right direction, we need to do better. The Friedrich-Ebert-Stiftung's office in New York is pleased to share with you some news on our recent activities. Your feedback is - as always - highly welcome.
