Few events have shocked the world as much as the deadly terror attacks of September 11, 2001. In the aftermath of 9/11, countermeasures, among them, the ultimately disastrous military interventions in Afghanistan and Iraq, were devised around the globe.

Today, 20 years later, we also know that the attacks of 9/11 had a decidedly negative effect on civil liberties worldwide. In a new comparative *anti-terrorism study* for FES New York, renowned expert Dr. Josef Braml examines the national anti-terrorism laws passed by G20 states in the wake of 9/11.

The results are worrying and remind us that fundamental democratic principles, such as the rule of law, should never be taken lightly. While authoritarian states thus continue to use the "war on terror" as a welcome excuse to silence dissent and unwanted opposition, results also show that democratic states are keeping restrictions on civil liberties and privacy - once envisioned as only temporary - in force until this day.

As we continue to reckon with the legacy of 9/11, FES New York is pleased to support an 8-part special series of *WarPod* podcast by Saferworld, which takes a comprehensive look at the consequences of 9/11 across the world.
